Yet they triggered important system changes and paved the way for significant new health policies.

The complex outcomes of the reforms included

- o changes in the quality, efficiency and costs of care
- o growing managerial and political control over physicians and other health care professionals
- o increased influence and centrality of community-based care
- o Diffusion of ideas and practices from business management into health care.

He has taught at the State University of New York at Stony Brook and the School of Management at Boston College and has been a Visiting Scholar at Brandeis University, Georgetown University, Harvard Business School, and the Nordic School of Public Health.
